Over the past year the Accreditation Standard Teams and the Accreditation Editing Team have been writing the narrative, editing drafts, meeting with committees, and gathering feedback to develop the attached pdf draft of the LMC ACCJC Institutional Self-Evaluation Report (ISER) 2020. For example, if I serve on Planning Committee and I am interested in reviewing the standard(s) predominantly associated with planning, institutional effectiveness and research then I would open up Standard I and type "planning" in the find box. Adobe will find and highlight the word where it appears in the report.
