It is unfortunate that most of you fail to see how my injuries have affected my ability to be present on campus as well as elsewhere.

Due to this injury I have lost 10 hours from work a week. I used to work 20 and it has been permanently reduced to 10.

I was disqualified from UC Berkleys ROTC due to my inability to train and I am once again rejected by the board due to a distaste for my attitude.

Unfortunately for those people, I am no longer asking for a leave of absence.

I am physically injured to the point of hospitalization 2x a week and I will no longer be attending the Imcas meeting, until I am better.

It is saddening and extremely disheartening to see my once ambitious friends be so cruel and heartless. I am terribly ill and all you can think about is how my attitude affects you, Rather then how it pains me to even walk? I know now my opinions that have been formed, are right.

I will see you when I am better but until then I must take the time to heal.
