What is "Comprehensive Program Review"?

According to Program and Course Approval Handbook

"Colleges are required to periodically review curriculum in a process called 'program review' during which faculty and administrators review the program requirements and course content in consultation with advisory groups. Program Review is a planning process whereby academic departments determine the future needs and goals of their educational programs."

According to ACCJC

"The institution demonstrates strong commitment to a mission that emphasizes achievement of student learning and to communicating the mission internally and externally. The institution uses analyses of quantitative and qualitative data and analysis in an ongoing and systematic cycle of evaluation, integrated <u>planning</u>, <u>implementation</u>, <u>re-evaluation</u> to verify and <u>improve</u> effectiveness by which the mission is accomplished."

According to ACCJC

"The institution assures the effectiveness of its ongoing planning and resource allocation processes by systematically reviewing and modifying, as appropriate, all parts of the cycle, including institutional and other research efforts."



- Strategic plans Interim and 5 year District and LMC plans; and program/unit plans
- Assessment Annual Course Level (CSLO) and 5 Year
 Program Level (PSLO) assessment
- Course Outlines Updated at least once in 5 years
- Program Review Annual updates and 5 Year
 Comprehensive PR
- Resource Allocation Annual; tied to planning and assessment to improve student success, institutional effectiveness
