| Wednesday, March 2 | Business Office Director collates and submits RAP requests to the President's expanded Cabinet for review. |
| Wednesday, March 9 | Expanded President's Cabinet meets to review Program Maintenance requests and ensure that all other proposals (Program Improvement and Development, Perkins IV and Permanent Classified Staffing) are completely filled out—with appropriate information that will help facilitate further review and assessment by the Shared Governance Council (SGC) and the President. |
| Thursday, March 10 - Wednesday, March 16 | Representatives from President's expanded Cabinet obtain additional information—for proposals identified as incomplete or needing more information—and submits to the Business Office by Wednesday March 16 th by 5:00 pm. |
| Thursday, March 17 | Business Office sends: Program Improvement and Development and Permanent Classified Staffing proposals to the Shared Governance Council; additional Perkins IV information to the Dean CTE & Social Sciences; and any additional information for Program Maintenance proposals to the President. |
| Wednesday, March 30 | Shared Governance Council meets to view presentations of Program Improvement and Development and Classified Staffing proposals. Designated managers (along with proposers) present proposals to SGC. |
| Wednesday, April 6 | If necessary, Shared Governance Council meets again to view remaining RAP presentations. |
| Friday, April 15 | By noon, Shared Governance Council voting members submit rating sheets for Program Improvement & Development and Classified Staffing proposals to the LMC Business Office. |
