## Suggestions Offered:

• Include the transfer objective under Priority #1 on the detailed schedule – it fell off.

- Clarify in Priority #2 that all employees will be surveyed
- In Priority #4, the Objectives correctly address 'transferred prepared' but the baseline data might address 'transfer ready.'
- Priorities #3 and #4 should replace "focus" with "improve" to make it more active.
- We need a mechanism to make sure the institution actively pursues each of these strategic priorities starting in the fall.
- We look at the percentage increases to make sure they will make the institution reach for better results; that is, they are not too easy to attain, but they should not discourage the institution if not reached.
- We should reconsider use of transfer data to private and out of state colleges and universities, particularly if their numbers are changing from year to year, and our students are transferring to these institutions because CSU and UC are reducing transfers. Plus we need to account for the overstatement of University of Phoenix transfer.
- We could consider use of clearinghouse transfer data as that database becomes more reliable.
