

## athways to success 2023-2024 FINANCIAL AID DISBURSEMENT POLICY AND CALENDAR

Pell Grant Policy: Disbursements are prorated based on enrollment status for classes starting within 10 days of the Award Calculation Date. Disbursements occur twice each primary semester (fall and spring) and once for summer (if eligible). Pell Grant is recalculated each primary semester based on enrollment status prior to these dates: October 16, 2023, for fall 2023 and March 18, 2024, for spring 2024. Students whose enrollment status decreases on or before these dates may be subject to repayment of all or a portion of aid disbursed.

**Cal Grant Policy:** Disbursements are prorated based on enrollment status at the time of disbursement for each primary semester. Cal Grant requires at least 6 units to qualify.

**Other Awards:** Disbursement is based on enrollment status prior to the Award Calculation Date. FSEOG and Direct Loan requires 6 or more units to qualify; Student Success Completion Grant requires 12 or more units.

**Student Account Charges:** Financial aid funds (excluding EOPS and some scholarships) will be applied toward current student account charges. Remaining financial aid balances after charges have been paid, if any, will be refunded to the student according to the Disbursement Calendar below. To view student account charges/payments, log onto InSite, click the Payment tile, then Account Activity.

**Withdrawal:** Students may be required to repay all or a portion of federal aid disbursed if they withdraw from all courses before 60% of the course length. **For full semester courses, the 60% dates are:** 

October 25, 2023, for fall 2023

April 3, 2024, for spring 2024

**Deadlines:** A valid, processed FAFSA/CADAA must be received by the last day of the last semester the student is enrolled for the academic year. Students must submit all required documentation by the Final Documentation Deadline based on their last semester of enrollment for the academic year:
