#### Mission/Goals

# Describe the purpose and goals of the program. Who is it designed to serve? Will the program offer an Associate Degree? A Certificate of Achievement?

The purpose of this program would be to create a short certificate that is approachable and easily achievable for students who are currently pursuing the Graphic Communications degree program at LMC, and for working students looking to complement their existing skillset, to accommodate changing demands of their current job, or to make themselves more attractive when applying to a four-year photography program at a University.

#### <u>Rationale</u>

# What role would this program fulfill in the college curriculum? Why is it important to offer this program?

Currently, LMC does not offer any program specific to Photography. The current Photography courses offered are electives for the Graphic Communications and Fine Arts Degrees. As a student of Graphic Design, I found myself excelling at the photography courses. However, when applying for even the lowest level photography positions, an impressive photography portfolio was not enough to be noticed in the application process. This is exacerbated by the fact that many job applications have no opportunity for the inclusion of a portfolio document, but do have opportunities to include certificates or extra training and experience.

Also, I wanted to transfer to a four-year school to study photography, but I could not substantiate that I had real training in photography even though I received an excellent education from the LMC art department. LMC students seeking to transfer to a Bachelor's program in photography at any university have no way to validate their photography skills beyond including a photography portfolio, but given the ubiquitous nature of cameras and photographs, self-proclaimed photographers are a dime-a-dozen, and it is necessary to differentiate oneself from the crowd.

Years later, I find that my individual experience was not unique. Many of my photography students express a desire to work in the field of photography or transfer to a four-year photography program but struggle to do so, and there is currently no solution I can offer them.

Graphic Design is a growing field, but in the current climate it is often blended with other positions. In order for graphic designers to stand out in the application process, they need to have cross-training in other fields, such as photography, film, computer programing, or animation. A Certificate of Achievement in Photography will pair well with the existing degree program in Graphic Communications and show potential employers that the candidate has already been formally trained in an area outside of Graphic Design.

On the recommendation from the CTE committee that we add short certificate programs within the art department so that working people can return to school for an "upskill," this certificate program would fit that description precisely for working individuals who need or desire extra training in photography.

## ART-072 Introduction to Digital Photography (3 Units)

An intensive introduction to both the technical and artistic principles of Digital Photography. Learn to communicate a story or message with photographs, and learn Photoshop adjustments that help sculpt the photographer's vision for the photograph.

## ART-074 Photo II: Developing a Personal Vision (3 Units)

Learn advanced photoshop techniques, practice conceptual thinking, and develop creative problem solving by planning and carrying out an independent photographic project that the student proposes under the guidance of the instructor.

## ART-019 History of Photography (3 Units)

This course examines the history of photography from its invention to the present and addresses technical, artistic, and social underpinnings of the art and science of photography. This course discusses processes, the work of major photographers, aesthetic movements, and artist groups that shaped the course of the medium, and how these influenced the course of history.

Do other colleges in the district or in neighboring districts offer a similar program? If so, provide the rationale for duplicating it at LMC.

DVC has a Certificate of Achievement in Photography; however, there is a larger requirement of courses that include a broader education in art history. It is also on-campus.

LMC's Certificate of Achievement in Photography would be more specifically tailored to photography only, which is better suited for CTE recommendations. Additionally, all the included courses are currently approved for online instruction, giving this a potential to be an entirely online certificate program and thus not restricted to LMC art program enrollment and potentially reaching a broader population of students.

Beyond that, there are only a few photography certificate programs online in the State of California, mostly offered by universities, having a much larger requirement of courses, some of which require access to darkrooms and/or expensive equipment. The combination of these factors makes these programs cost thousands of dollars to complete and irrelevant to the student desiring a certificate to gain acceptance into the university in the first place. It also makes these programs less attractive for working students looking to quickly gain a skill that makes them a more attractive employee, to supplement their existing role at a company, and often becomes too challenging to achieve while working toward an unrelated degree program. Moreover, the vast majority of positions in the work force currently have no need for an employee with knowledge of darkroom procedures

and processes, and a tailored education in digital photography is more relevant for our online and computer-based workplaces.
