1. Report-Outs
 - a. Louie: Local GE vs State standards, If a course meets state standards, does it need to meet Local GE? Sara- Course go to GE first to catch problem that can be returned to department before coming to Curriculum. Adrianna- GE prefers the term Stop, just as Tech Review has a Stop.
