7. Ethnic Studies

Josh shared CSU has a new ethnic studies requirement. A taskforce is recommended to review and discuss how to satisfy the new requirement, plus review the local multicultural requirements before making any changes. Rikki further explained that Title V indicates students can meet one out of three patterns with their AA degree (CSU/IGETC or local GE). With the local requirement, students meet the additional multicultural requirement, compared to CSU/IGETC may have other additional areas to satisfy their GE requirements. Taking into consideration that the multicultural requirement is not a Title V required area. Cindy shared the intentions of revising the GE model was to solve two concerns. One, the LMC's GE pattern offers students' flexibility among their course offerings, particularly for students who don't transfer (CTE and local degrees). Second, the LMC multicultural requirement offers a broader scope of focus outside of the ethnic studies requirement. In considering the new GE model, some courses may not meet transfer or ethnic studies/multicultural requirements, which these courses will be identified with a special mark, e.g., asterisk, so students are aware that certain courses meet on local GE requirements. This topic well be add as an agenda item for consideration as a spring Flex topic

Governance Committees

- 1. <u>Shared Governance</u> Morgan provided an update of the SG committee discussion, e.g., budgeting regarding the RAP process and awareness about the overall budget. Nikki shared that SGC discussed EMP and that Chialin provided a program review presentation focused on procedures and processes. Morgan shared that TLC is modifying eLumen to rollout the assessment component.
