- Pre/co-requisite are updated, reviewed, and approved every six years, except CTE every two years.
- Major course revisions are changes to: CSLOs, units, content, and methods of evaluation.
- Separate votes are needed for new COORs and existing COORs with major revisions, pre/co-requisite, online addendums, and assignments.
