4. GE Office Hours: Funding proposal update for AB928 & AB 1111

Adrianna submitted 2 proposals for funding. For each funding source, Adrianna requested \$5000 as a starting point, \$10000 total. There is a course by Lucy Snow, which needs AB928 support. Adrianna will know the outcome on January 21st, 2025.

The committee questioned the scope of help the members would be able to provide, and after discussion settled on the understanding that the AB928 funding would be for new courses, and for the courses that exist, the committee may provide help by providing suggestions on how to align to boxes, if the alignment is possible. Further, the committee member that steps up to assist would not be making alignment decisions unilaterally. The person assisting those requesting assistance would return to the committee to have a committee vote. The committee would act as a mediary between the faculty requesting assistance, and the eLumen final step.

The Steering Committee and Office of Instruction have preliminary deferred 5 hours of pay per course but are aware and prepared if 5 hours are not enough.

Sara volunteered to work with Lucy on the course requested and mentioned earlier.

Adrianna notes that the committee has been already working on the English Common Course numbering, and Adrianna would like to have the Steering committee consider covering those hours retroactively.

Sara & Cindy & Adrianna plan to attend the English department meeting at the beginning of SP25, since as of right now, the English 100 course is not in alignment with the local GE pattern

5. GE Spring & Fall 2025 Work: Next steps and work for local GE
