**4. GE Office Hours: Update on AB 928 & AB1111 work**

The committee received funding for AB 928. The committee did not get approved for the AB1111 work. Adrianna can ask the English department to work together to write another AB1111 proposal, if the GE committee would like to.

**5. GE Spring & Fall 2025 work: GE Handbook work/updates**

The committee reviewed the current GE pattern, and wrote down the expected mapping to provide for Grace Villegas to use for eLumen mapping that Adrianna Simone will email after the meeting concludes. This includes the renaming of boxes from actual names to “Area 1”, “Area 2” and so on to match the state, all but, Ethnic Studies, which can stay in area 6.

Eloine Chapman has requested GE committee review if the SLO descriptions require updates. The committee discussed last (December) sub group’s discussions where one group came to the conclusion whereby the Diverse Perspective’s description was advised to remain the same, while the Ethnic Studies sub group recommended the new description to read as: “At the completion of the LMC GE program, a student will be able to analyze the effects of race, racism, and white supremacy as it impacts the local state, national, and global power dynamics and understand the contributions of Black, Native American/Indigenous, Chicanx, Latinx, Asian American, Pacific Islander, or another community of color that dismantles racist power structures.” [DRAFT]
