# 4. GE Tech Review: Coor review with GE teams

BIOSC-007's course outline of record is reviewed by the committee. One of the committee members notes that the course outline does not demonstrate GESLO 5, because there is no direct connection to the "quantitative" portion of quantitative reasoning. The committee took a closer look at the Lab Summary Question, where the GESLO5 is mapped. One of the members specified that without the Lab Summary Question, it would be difficult to ascertain if the GESLO5 fits, but it is more agreeable that it does, after reviewing the sample. The committee is in agreement that it seems impossible to conduct the class without implied use of quantitative reasoning.

BIOSC-040 was reviewed. One of the committee members notes that the word "hypothesize" is directly linked to the scientific process. Members of the committee were skeptical about the Scientific Inquiry being present in the course outline. It may be beneficial to add "validate" to the Sample Method of Evaluation for Scientific inquiry. The committee notes that the course outline holds only anatomical systems/organs listed. The committee consulted the <a href="How to Integrate GE SLOs into COORS">How to Integrate GE SLOs into COORS</a>, and noted that under the proposed assessment criteria section c, the course outline does not satisfy scientific inquiry without an explicit statement of validation of hypothesis claim. Committee members note that the course outline author seems to be amicable to feedback.
