## GENERAL APPLICATION INFORMATION

1. This handbook applies to requirements for admission into the Registered Nursing Program for **Fall 2026**.
2. The application, selection, and admission processes for the Registered Nursing Program are coordinated by the Admission and Records Office and any inquiries regarding applications should be directed to this office. The links to the application forms will be posted on the website during the established application deadline dates.
3. Funding by the State Chancellor's Office mandates all nursing applicants to take the ATI TEAS Test Version VII. The "cut scores" have been set at 62%. Please note:
  - a. The ATI TEAS Test Version VII will be administered **ONLY** to those applicants who have been advanced to Phase II of the selection process.
  - b. Only the score from the first two attempts at the current version of the ATI TEAS Test (as reported by ATI) will be considered for full acceptance to the nursing program regardless of when or where it was taken.

## ASSOCIATE DEGREE NURSING (ADN) PROGRAM REGISTERED NURSING

### Program Description

The Associate Degree Registered Nursing Program takes two academic years to complete beyond the completion of the prerequisite courses. Graduates who successfully complete the prescribed college requirements and the prescribed nursing curriculum earn an Associate of Science Degree in Nursing (ADN) and are eligible to take the examination for licensure as a Registered Nurse in California Next Generation (NGN).

The Registered Nursing Program content is drawn heavily from the sciences and general education. The emphasis is on the utilization of the problem-solving process, making nursing judgments, and learning leadership skills.

The Los Medanos College Registered Nursing curriculum is based upon the basic standards for the competent performance of a nurse as defined in the **Rules and Regulations, California State Board of Nursing:**

#### **CCR 1443.5 Standards of Competent Performance.**

*A Registered Nurse shall be considered to be competent when he/she consistently demonstrates the ability to transfer scientific knowledge from social, biological, and physical sciences in applying the nursing process, as follows:*

- 1. Formulates a nursing diagnosis through observation of the client's physical condition and behavior and through interpretation of information obtained from the client and others, including the health team.*
- 2. Formulates a care plan, in collaboration with the client, which ensures that direct and indirect nursing care services provide for the client's safety, comfort, hygiene, and protection, and for disease prevention and restorative measures.*
- 3. Performs skills essential to the kind of nursing action to be taken, explains the health treatment to the client and family, and teaches the client and family how to care for the client's health needs.*
- 4. Delegates tasks to subordinates based on the legal scopes of practice of the subordinates and on the preparation and capability needed in the tasks to be delegated, and effectively supervises nursing care being given by subordinates.*
- 5. Evaluates the effectiveness of the care plan through observation of the client's physical condition and behavior, signs and symptoms of illness, and reactions to treatment and through communication with the client and health team members, and modify the plan as needed.*
- 6. Acts as the client's advocate, as circumstances require, by initiating action to improve health care or to change decisions or activities which are against the interests or wishes of the client, and by giving the client the opportunity to make informed decisions about health care before it is provided.*

## **Program Philosophy**

The ADN faculty believes that we can best serve our community by educating its future Registered Nurses to a recognized standard of excellence. We are committed to helping promote success in our students. To achieve this goal, we try to create a learning environment that emphasizes critical thinking, respect, and community service. We honor the cultural diversity of our community and encourage enrollment in our program by members of all of its many groups. We promote career advancement by offering a “Transition” that admits Licensed Vocational Nurses who meet our admissions criteria into the second year of the Registered Nursing Program. We recognize the interrelationship of all knowledge and accordingly place a strong emphasis on general education. The LMC graduate Registered Nurse is educated for full participation in the life of the community, both as a citizen and a professional member.

## **GENERAL EDUCATION and GRADUATION DEGREE REQUIREMENTS LOS MEDANOS COLLEGE**

It is strongly suggested that the General Education courses and Graduation Requirements be completed prior to entering the RN Program.

If you have an Associate's degree or higher from another college or university, request that official transcripts are sent to the Admissions and Records at LMC for evaluation prior to making an appointment within an LMC counselor.

Applicants who have completed college courses at another, but have not earned a Bachelor's degree or higher will need to satisfy Los Medanos College's General Education and Graduation requirements.

### Prerequisite Courses

All prerequisite courses must be completed by the Fall semester before you apply. Courses that are “in progress” do not qualify. Please refer to the LMC Catalog for course descriptions. Catalog Rights do not pertain to prerequisite courses. There is no recency requirement for prerequisites.

Please refer to the Multi-Criteria Screening Process on pages 14-16 for information on how many points are allocated for each section.

<b>Science Prerequisites:</b> Must have a grade of “B” or better (“B-” is not acceptable) with an overall GPA of 3.0 or higher in these three courses. <i>Note: Virtual/ online lab courses will be accepted if completed in Spring 2020 or thereafter. Online lab courses completed before Spring 2020 do not qualify.</i>

## **ASSOCIATE DEGREE NURSING (ADN) REGISTERED NURSING PROGRAM CURRICULUM**

The Registered Nursing Program takes 2 years (4 semesters) to complete beyond the prerequisites. An average weekly schedule includes 5 hours of lecture, 3 hours of lab on campus, and 18.5 hours clinical experience every week.

Lectures are typically on Mondays and Tuesdays during the day and clinical practice on Thursdays and Fridays on the day or the evening shift. Please be aware that due to the increased demand for clinical placement by nursing schools, clinical practice may also be scheduled on another day during the week or on weekends. Students may be expected to visit the clinical site the day prior to clinical to gather data on assigned clients.

Clinical practice will be provided in a variety of local healthcare facilities and specialty areas. Students **MUST** provide their own transportation.

## **LOS MEDANOS COLLEGE ADN PROGRAM APPLICATION PROCEDURE**

Applicants are selected for the Los Medanos College Registered Nursing Program from the qualified applicant pool. Meeting the minimum requirements does not guarantee admission.

### **Minimum Requirements for Qualification for the RN Applicant Pool**

- A. All prerequisite courses must be completed by the end of the Fall semester before you apply.
- B. Refer to pages 14-16 for the Multi-Criteria Selection Process which details the minimum grade point average required in the prerequisite coursework to qualify for the RN Program.
- C. Submission of all required application materials to the Admissions and Records Office by the application deadline.

### **Application Process**

1. New and returning students who have not enrolled within the Contra Costa Community College District (4CD) within the academic year must complete the online admission application for Los Medanos College.
2. Submit the RN Program Application online (the application link is posted to our website during the established application dates)
3. Submit all application documentation by the application deadline:
  - a. Official college transcripts for courses completed outside the Contra Costa Community College District (CCC, DVC, LMC) to the Los Medanos College Admissions and Records Office by the application deadline. Official transcripts for ALL lower-division courses completed at all regionally accredited U.S. institutions attended, regardless of applicability to nursing requirements, are required. Students may view the receipt of official transcripts using the Grades – Transcripts tile on InSite. Transcripts received after the application deadline will not be considered.
  - b. Any other supporting documents required for points earned in Phase I must be uploaded using the online application by the application deadline. Supporting documents submitted after the application deadline will not be considered.
  - c. International student transcripts are only applicable if the student has demonstrated equivalency of a BA/BS or higher; if so, the applicant may earn points in the multi-criteria screening for their degree. Foreign transcripts **MUST** be officially evaluated by an approved international transcript evaluation service. Students must select an approved member of NACES (National Association of Credential Evaluation Services) by visiting [www.naces.org](http://www.naces.org). Please check with the Admissions and Records Office for specific information that needs to be included

in the evaluation. The NACES evaluation will be used ONLY to award points as part of ADN admission criteria – possibly not for graduation purposes.

4. Upon submission of the RN Application, applicants will be directed to a screen verifying their confirmation of submission. Applicants will also receive a confirmation email in their InSite email inbox. These are both documentation that the applicant's submission was received. All applicants, both new and those who have previously applied to the Los Medanos Registered Nursing Program, will be given the same priority regardless of the number of times the applicant has applied. **APPLICANTS NEED NOT APPLY MORE THAN ONCE.**

## LOS MEDANOS COLLEGE ADN PROGRAM SELECTION PROCEDURE

### Multi-criteria Screening Process for Admission to the Registered Nursing Program

Selection is determined using a multi-criteria screening process in accordance with California Education Code 78261 and the California Community College Chancellor's Office directive. A multi-criteria score is determined for each candidate based on previous degrees/certificates, licensure or certification in healthcare, GPA in identified coursework, life experience or special circumstances, foreign language proficiency, and diagnostic assessment. Program admission will be offered to the highest-scoring eligible applicants to fill available seats.

#### 1. Phase I Online Application Evaluation

- a. The Admissions & Records department is responsible for evaluating applications. The evaluator will carefully examine transcripts, determine course equivalencies, and verify supporting documents. Each applicant will be given a score based on the Phase I criteria outlined on pages 14-16. The maximum possible score is 75.

#### 2. Phase II Notification and TEAS Exam

- a. **Phase II Notifications:** The applicants with the highest scores in Phase I will advance to Phase II. Once all applications have been assessed, Phase II Notifications will be sent to applicants' InSite email addresses. It is imperative that you regularly check your InSite email as this is the sole means of notification.
  - i. **The Phase II Notification Email** will contain the Phase II Notification Form, along with a set deadline for its submission. To ensure their participation in Phase II, applicants must fill out and submit the form before the deadline. If we do not receive a response from the applicant by the established deadline, the applicant will lose their chance to advance to Phase II and will need to reapply in the next application period.
  - ii. **Information regarding the TEAS Exam:** Phase II points are determined by the score received on the TEAS Exam. Beginning in 2024, the Los Medanos College Nursing Program will accept the TEAS Exam results from the first or second attempt at the current version. Applicants may take the exam before they apply but will only be asked to submit their ATI transcripts if advanced to Phase II.
    1. **TEAS Exam at LMC:** Phase II applicants who have not exceeded two attempts of the current version of the TEAS Exam will be invited to take the TEAS Exam at Los Medanos College. The Phase II Notification Email will include information regarding the date and time the TEAS exam will be scheduled at LMC. Students intending to take the exam at LMC will indicate this on the Phase II Notification Form. There is generally only a two-week period between the time applicants are notified to the time the exam is scheduled, we recommend that all applicants prepare for the test.
    2. **Submitting TEAS Exam Results from a previous attempt:** The Los Medanos College Nursing Department will accept a TEAS score from a previous attempt. If advanced to Phase II, students may submit their official ATI transcript from their first or second attempt of the current version of the TEAS Exam.

- a. Previous TEAS attempts proctored in-person or online by ATI, PSI, or another learning institution are acceptable.
    - b. Students submitting their TEAS Exam score from a previous attempt will indicate this on the Phase II Notification Form. Transcripts must be submitted by the deadline established in the Phase II Notification Email.
    - c. Official transcripts are received directly from ATI.
    - d. **DO NOT SEND YOUR ATI TRANSCRIPT UNLESS YOU ARE ADVANCED TO PHASE II AND HAVE RECEIVED INSTRUCTIONS FOR SUBMISSION.**
  - b. **Phase II Scoring:** The passing composite or cut score for TEAS Exam is 62% or better. The TEAS Exam score will be the total points awarded for Phase II of the selection process. For example, if the applicant scored 74.5 on the current version of the TEAS Exam, 74.5 is the total points for Phase II and will be added to the applicant's Phase I points.
  - c. **Disqualification:** If you do not meet the minimum cut score of 62% on the TEAS Exam, you are disqualified. Disqualified applicants may apply again during the next application cycle and retake the TEAS before next year's Phase II deadline.
  - d. **Remediation Program:** Due to the policy change allowing two attempts at the current version of the TEAS Exam, beginning in 2024, the Los Medanos College Nursing Program will no longer be offering TEAS Remediation.
3. Conditional Acceptance
- a. After completion of the TEAS Exam and receiving all exam scores, the scores from Phase I and the TEAS Exam (Phase II) are combined to calculate the final score for each applicant in the multi-criteria screening process.
  - b. **Conditional Acceptance Notifications:** The applicants with the highest scores Conditional Admittance will be offered to the applicants with the highest total score from Phase I and Phase II.
    - i. The Conditional Acceptance Notification Email be emailed to applicants' InSite email addresses. The email will include the Conditional Acceptance Form and an established deadline for the form to be returned. Applicants must complete and return the form by the established deadline to secure their position in the program.
  - c. **Non-Acceptance** – Following the selection process, if the applicant's Student Identification Number (IDN) was not listed as conditionally accepted or alternate status on the Nursing webpage, and the applicant did not receive a conditional acceptance notification; the applicant was not selected for the program and should reapply during the next application period.

4. **Eligibility for admission into the Registered Nursing Program – Four Step Process:**

<b>Step 1</b>	Phase II Notification form is received in the Nursing Department by the deadline.
<b>Step 2</b>	<p>The Phase II Notification email includes the following information:</p> <ul style="list-style-type: none"> <li>• ATI TEAS Version VII Exam information and deadlines.</li> <li>• The test will be administered by LMC to Phase II applicants who have not exceeded 2 attempts of the current version of the exam.</li> <li>• Information on how to submit ATI TEAS Version transcript if the exam has already been taken.</li> </ul>

	<ul style="list-style-type: none"> <li>Do not take the test repeatedly. Only the scores from the first two attempts of the ATI TEAS Version VII, regardless of where or when it is taken, are considered for eligibility. The highest score out of the two attempts is used in Phase II.</li> </ul>
<b>Step 3</b>	Upon completion of the ATI TEAS Exam, the students with the highest combined scores from Phase I and Phase II will be conditionally accepted into the program. The Conditional Acceptance form must be returned by the established deadline to secure a position in the RN program.
<b>Step 4</b>	<p>Within two weeks of receiving the Conditional Acceptance form, the Nursing Department will email a packet to the applicant that contains:</p> <ul style="list-style-type: none"> <li>Background check information</li> <li>Drug testing information</li> <li>Immunizations and health requirements</li> </ul>

**5. Not eligible for admission into the Registered Nursing Program if any one of the following is present:**

- Conditional Acceptance Form – Not submitted by the established deadline.
- Background Check – Not cleared by the established deadline.
- Drug testing information – Not cleared by the established deadline.
- Immunizations and health requirements – Failure to comply and meet established deadlines.

**6. If “Not eligible”, please refer to the Nursing Application Handbook for the next application date.**



## REGISTERED NURSING PROGRAM INFORMATION

### **If accepted into the Program, the student must be able to:**

- Accept clinical schedules, including evenings and/or weekends. Typical hours are generally 0645-1500 or 1445-2300. Evening shifts may be on Wednesdays and Thursdays or Thursdays and Fridays or Saturdays and Sundays. Flexibility is required due to clinical site availability.
- Spend a minimum of three hours/week in the simulated lab (RNURS 23, 27, 33 & 38).
- Meet health requirements set forth by clinical facilities including providing documentation for the following:
  - Physical Exam
  - a negative two-step tuberculosis test (required before the start of the program and annually) or a normal chest X-ray
  - Measles, Mumps, Rubella, Varicella, and Hepatitis B titers
  - Tdap vaccination
  - COVID-19 Vaccination
  - Students must comply with any additional physical requirements such as flu shots on an annual basis or other mandates required by the clinical agencies
- The student is responsible for all expenses incurred by any medical visits and vaccines. The student must be covered by personal health insurance throughout the program. Due to the demanding physical rigors of the nursing programs, each student must meet the physical requirements stated in the Appendices.
- Submit proof of current CPR certification prior to the start of the program and annually. All CPR courses must be approved by the American Heart Association. If an online CPR course is taken, it must have a lab check-off component.
- Meet assigned clinical facilities' requirements for employees/volunteers. Clinical facilities have the right to decline the acceptance of any student who does NOT meet the clinical facility's requirements.
- Comply with and meet the physical requirements outlined in the Essential Functions for nursing students listed in the Appendices.

All CSUEB BSN courses are online except for one field experience course. The one course that requires in-person attendance is Community Health Practice.

### **ADN-BSN Concurrent Enrollment Program Admission Requirements**

- Student has met all LMC RN Prerequisites and qualification requirements and has been conditionally admitted into the LMC Associate Degree of Nursing Program
- Completion of additional prerequisites for [CSU General Education – Breadth Requirements](#) for CSUEB:
  - Chemistry for Health Sciences with lab
    - LMC courses that meet this requirement: CHEM 006, CHEM 007, CHEM 025, or CHEM 028
  - Public Speaking or Interpersonal Communication (GE Area A1)
    - LMC courses that meet this requirement: SPCH 110 or SPCH 120
  - Elements of Statistics and Probability
    - LMC course that meets this requirement: MATH 110
  - Critical Thinking (GE Area A3)
    - LMC courses that meet this requirement: PHIL 110, PHIL 120, ENGL 220, ENGL 221, ENGL 230, ETHN 102, or SPCH 120
- Meet the following CSUEB LMC Concurrent Enrollment Program additional admission requirements:

### **ADN-BSN Concurrent Enrollment Program Application Procedure**

Only students who have applied and have been accepted to the LMC ADN program qualify for the ADN-BSN CEP Application.

1. **APPLY:** Once students are conditionally admitted to the LMC ADN Program, they will be provided with information on the ADN-BSN CEP application, including the application link and an established deadline for submission.
2. **SUBMIT:** Submission of all other documentation will be due by the established deadline. This includes official transcripts from any learning institutions where the additional CEP requirements were completed.

### **ADN-BSN Concurrent Enrollment Program Selection Policy**

- Only students who meet all CEP admissions requirements and meet all established deadlines will qualify for consideration.
- If there are more qualified applicants than available positions in the CEP, applicants will be ranked based on their combined scores from Phase I and Phase II of the Multi-Criteria screening process used in the ADN application.

## POLICY GUIDELINES FOR MILITARY PERSONNEL NURSING ADMISSION

Military Personnel and Veterans may be eligible for enrollment into the Los Medanos Associate Degree Nursing Program based on the following requirements:

\*Military students who were not successful in a previous Nursing Program are not eligible to apply for admission to the Nursing Program as an Advanced Placement Student.

1. Verifiable education and experience within the last five years prior to application. (Competency may be verified for each course per program policy.)
2. Education and experience meet the requirements of the LMC ADN Program guidelines.

The following pathways are established to assist with obtaining nursing credit for previous military education and experience.

**Pathway I-** Military Health Care providers who receive a formal training and have appropriate practical experience may apply for **admission as an Advanced Placement student into the second semester** of the Nursing Program. Individuals included: Air Force Basic Medical Technician, Army Medic, Health Specialist, other Medical Healthcare Providers with relevant training and experience.

- a. Review Official Joint Services Transcripts to determine course credits. Core classes may be evaluated by the college for challenge availability.
- b. Evaluate transcripts for prerequisite courses such as Anatomy, Physiology, Microbiology, Communication, English, and natural and social sciences coursework
- c. The LMC Nursing Department may evaluate an individual candidate's knowledge and skills levels in a formal test and/or exam, in addition to evaluation of his or her training and experience.
  - a. Skill evaluation will include a formal skills testing of any minimum of four, not to exceed eight skills covered in the academic terms preceding the term the candidate is being admitted to.

**Pathway II-** Including but not limited to (Navy Hospital Corpsman) or USAF, Independent Medical Duty Technician, (IDMT 4 N 0 X 1), Basic Medical Service Technician or Army Medical Specialist with an active California LVN license (Licensed Vocational Nurse) either through challenge (BVNPT Method 4) or successful completion of an LVN, LPN program.

- a. Admission credit will be given to applicants as an LVN to RN candidate per LMC ADN admission policies. The LVN-RN Advanced Placement students will be placed in the third semester of the RN program
- b. Admission to the program is on a space available basis as any LVN to RN Advanced Placement student
- c. All ADN prerequisites must be completed prior to application to the program
- d. Associate degree may require additional coursework per college policy
- e. Admission requirements will be the same or similar for all students

Note: Military records and transcripts must be reviewed by college admissions/records and the applicant must have an official DD214 showing service/discharge under honorable conditions. Applicant must also have evaluation reports (EPR's/CCR's) showing completion of military coursework/experience, and patient bedside care.

## **RN PROGRAM ASSOCIATE DEGREE ADVANCED PLACEMENT / TRANSFER ADMISSIONS PROCEDURES**

Qualified applicants may apply for advanced placement or transfer into the RN program.

**Advanced placement** is defined as:

- applying for **readmission** into the LMC Nursing Program at a level beyond the first semester within two years of the last attendance in the LMC Registered Nursing Program.
- applying for **readmission** into the LMC **LVN-RN Transition**.

**Transfer** is defined as:

- **applying for admission** into the LMC Registered Nursing Program at a level beyond the first semester after having completed registered nursing coursework at another college.
- **All nursing courses must be completed at the time of application in order for the transfer application to be considered.**
- **Transfer applications with “In progress” nursing courses will not be considered.**

All Advanced Placement / Transfer applicants will be considered for admission based on a space-available basis only. Available space(s) will be filled according to the following selection priorities:

1. Los Medanos College Nursing students applying for Advanced Placement
2. Qualified LVN to RN Transition Students (if applicable)
3. Transfer Students
4. Qualified Non-Degree applicants

### **Minimum Requirements for Qualification for Advanced Placement/ Transfer**

- A. Meet the minimum requirements for the RN program (pg. 9).
- B. Complete courses equivalent to those required in the curriculum prior to the semester of application (see ADN Program Curriculum pg. 11).
- C. Submission of all required application materials to the Admissions and Records Office by the application deadline.

**Application Process** for Advanced Placement/ Transfer are as follows:

1. New and returning students who have not enrolled within the Contra Costa Community College District (4CD) within the academic year must complete the online admission application for Los Medanos College.

2. Submit the application online (the application link is posted to our website during the established application dates)
3. Submit all application documentation by the application deadline:
  - a. Official college transcripts for courses completed outside the Contra Costa Community College District (CCC, DVC, LMC) to the Los Medanos College Admissions and Records Office by the application deadline. Official transcripts for ALL lower division courses completed at all regionally accredited U.S. institutions attended, regardless of applicability to nursing requirements, are required. Students may view the receipt of official transcripts using the Grades – Transcripts tile on InSite. Transcripts received after the application deadline will not be considered.
  - b. Any other supporting documents required for points earned in Phase I must be uploaded using the online application by the application deadline. Supporting documents submitted after the application deadline will not be considered.
  - c. International student transcripts are only applicable if the student has demonstrated equivalency of a BA/BS or higher, if so the student may earn points in the multi-criteria screening for their degree. Foreign transcripts **MUST** be officially evaluated by an approved international transcript evaluation service. Students must select an approved member of NACES (National Association of Credential Evaluation Services) by visiting [www.naces.org](http://www.naces.org). Please check with the Admissions and Records Office for specific information that needs to be included in the evaluation. The NACES evaluation will be used **ONLY** to award points as part of ADN admission criteria – possibly not for graduation purposes.
4. Upon submission of the Advanced Placement/ Transfer Application, applicants will be directed to a screen verifying their confirmation of submission. Applicants will also receive a confirmation email in their InSite email inbox. These are both documentation that the applicant's submission was received. All applicants, both new and those who have previously applied to the Los Medanos Registered Nursing Program, will be given the same priority regardless of the number of times the applicant has applied. **APPLICANTS NEED NOT APPLY MORE THAN ONCE.**
5. **If requested** by the Nursing Department, transfer students must submit course outlines, syllabi or other materials giving evidence of previously learned content.
6. **Transfer applicants** may be required to pass a Math exam, a Theory and Pharmacology Exam on the content covered in the previous semester, and a Skills Competency Exam. If applicable, the transfer applicant may be required to pay for the cost of any exam or skills lab equipment used in the evaluation process.
7. Advanced Placement students are not required to take the assessment exams.

8. **Confirmation of Application Submission:** Once the online application is submitted, the webpage will immediately direct to confirmation of submission. The applicant will also receive an email confirming their application was successfully submitted.

### Conditional Acceptance

- Advanced Placement/ Transfer applicants are required to comply with the Eligibility for Admission – Three Step Process (See below)

### Eligibility for admission into the Registered Nursing Program Advanced Placement/ Transfer – Three Step Process:

## **DEFERMENT OF ADMISSION FOR APPLICANTS WITH A TEMPORARY MAJOR MEDICAL CONDITION**

This policy applies to an applicant who has submitted the Conditional Acceptance form and is **eligible for admission** into the Registered Nursing Program.

**This is considered an admission to the nursing program.**

In the event that the applicant develops or presents with a temporary health condition **before the first day of class** that interferes with the applicant's ability to meet the immunization or health requirements of the program, then the applicant may apply for a deferment of admission.

The deferment will be for only two (2) years. Therefore, the applicant needs to be prepared to enter within two (2) years as a readmitted student (see Additional Information #1).

### **Procedure**

1. Prior to the first day of class, the applicant must write a letter explaining the situation to the Director of the Nursing Program. Medical documentation indicating the applicant's inability to participate in clinical practice must accompany the deferment request letter.
2. The Director of the Nursing Program will review and discuss with the course faculty team the applicant's request and medical documentation. The Director will notify the applicant in writing of the decision of the faculty team.
3. The applicant must submit a new Nursing Application online during the next two (2) application periods.
4. The applicant must comply with any additional admission requirements listed in the Nursing Applicant Handbook for the current year of application.

### **Additional Information**

1. **A student may be readmitted to the nursing program one time only. Therefore, the new applicant, upon returning from deferment the following year, is considered to be readmitted and is no longer eligible for additional readmission.**
2. **Upon returning, the applicant will be required to complete a background check and drug screening.**
3. **If the applicant does not submit the nursing application within the two (2) year timeframe or is unable to begin the program within the timeframe, the granted deferment will not be extended.**
4. **A student may be readmitted to the nursing program one time only. A student who has previously been admitted to the RN program but was unable to complete the program for any reason, may NOT defer their second admission into the RN program.**

## **Essential Functions Registered Nursing Students**

The Americans with Disabilities Act (ADA) of 1990 was instituted by Congress to prohibit discrimination against qualified individuals with disabilities. The ADA defines a qualified individual with a disability as an individual who, with reasonable accommodations, can perform the essential functions of the employment position that such individual holds or desires. In addition, the Rehabilitation act of 1973 prohibits discrimination in the admission of a qualified person with disabilities.

Reasonable accommodations for students with disabilities, either temporary or permanent, will be considered on a case-by-case basis and in consultation with the Disabled Students Program and the clinical agencies as appropriate.

To enter into and to complete the nursing programs, nursing students must be able to meet the emotional, cognitive, and physical requirements listed below:

### **Emotional & Behavioral Requirements:**

The nursing program is a rigorous program, both in academic study and in the acquisition and practice of clinical skills. The student must have sufficient emotional stability to perform under stress and provide safe nursing care to clients in the clinical setting while being observed by the instructors and other health care professionals. Students need to demonstrate courtesy and professional consideration in all interactions with faculty, peers, nurses, staff, and administrators in the campus and clinical area. Students must be considerate in all their dealings as students represent as ambassadors for the college and the nursing profession in all their contacts. Behavior exhibited must never compromise safety of self and others.

### **Cognitive Requirements:**

The student must have sufficient cognitive ability to listen, speak, read, write, reason, and perform mathematical functions (addition, subtraction, multiplication, division, percentages, and fractions with or without a calculator), clinical reasoning and clinical judgment at a level that allows processing and understanding of materials and information presented either verbally, digitally, or in written format.

### **Physical Requirements:**

Nursing students are required to travel to clinical facilities (i.e., outpatient, acute care settings, skilled facilities) and to have the endurance to adapt to a physically demanding program. The following physical requirements are necessary for the nursing program:

1. **Strength:** Sufficient strength to lift, move, and transfer most clients, to restrain and carry children, to move and carry equipment, and to perform CPR according to the American Heart Association guidelines.

2. **Mobility:** Sufficient mobility to bend, stoop, and bend down to the floor; a combination of strength, dexterity, mobility, and coordination to assist clients; the ability to move around rapidly, and move in small, confined spaces. Be able to perform all physical skills required to deliver patient care such as CPR, ambulation, transport, reposition, lifting, and other nursing duties.
3. **Fine Motor Movements:** Required to manipulate syringes and IV's; to assist clients with feeding and hygiene needs; to write/compose documentation in charts and use computer keyboards; to perform sterile and other skilled procedures.
4. **Speech:** Ability to speak clearly in order to communicate with staff, physicians, clients, and families, and to be understood on the telephone.
5. **Communication:** Able to communicate in English both verbally and in written format so that students can communicate nursing actions, interpret client responses, initiate health teaching, and document observations, interactions, interventions, and nursing care. Document and understand nursing activities, and interact with clients, families, staff, and faculty.
6. **Vision/Visual Acuity:** Sufficient visualization to make physical & observational assessments of client health status and to accurately (skin tone, color changes, dermatological conditions, non-verbal behaviors, changes in signs and symptoms of illness/disorders, health improvement and/or deterioration, etc.), and safely use and apply client medications and equipment.
7. **Hearing:** Sufficient to accurately hear patients, monitor signs and symptoms, detect patient speech and voice; hear call lights; hear messages and orders on the telephone; be able to hear through a stethoscope to discriminate sounds; hear cries for help, to hear alarms on equipment and emergency signals and various overhead pages.
8. **Touch/Tactile Sensation:** Ability to palpate both superficially and deeply to discriminate tactile sensations and temperatures.
9. **Fine Motor Skills:** Sufficient motor skills of all fingers and ability to grasp and control medical equipment, and to perform precise procedures such as sterile dressing changes. Ability to grasp objects such as a pen to prepare handwritten reports or syringes for the accurate and proper administration of medications.
10. **Depth Perception:** Required for fine tasks such as administering injections, sterile catheter insertions (urinary, IV), and nasogastric insertions.
11. **Smell:** One must have a normal sense of smell to detect odors not only for ensuring proper hygiene to maintain and uphold patient dignity, but to detect odors indicating unsafe conditions or changes in patient health status.

Civil Code Section 1786.22.

1. An investigative consumer reporting agency shall supply files and information required under Section 1786.10 during normal business hours and on reasonable notice.
2. Files maintained on a consumer shall be made available for the consumer's visual inspection, as follows:
  - (1) In person, if he appears in person and furnishes proper identification. A copy of his file shall also be available to the consumer for a fee not to exceed the actual cost of duplication services provided. (2) By certified mail, if he makes a written request, with proper identification, for copies to be sent to a specified addressee. Investigative consumer reporting agencies complying with requests for certified mailings under this section shall not be liable for disclosures to third parties caused by mishandling of mail after such mailings leave the investigative consumer reporting agencies. (3) A summary of all information contained in the files on a consumer and required to be provided by Section 1786.10 shall be provided by telephone, if the consumer has made a written request, with proper identification for telephone disclosure, and the toll charge, if any, for the telephone call is prepaid by or charged to the consumer.
3. The term "proper identification" as used in subdivision (b) shall mean that information generally deemed sufficient to identify a person. Such information includes documentation such as a valid driver's license, social security account number, military identification card, and credit cards. Only if the consumer is unable to reasonably identify himself with the information described above, may an investigative consumer reporting agency require additional information concerning the consumer's employment and personal or family history in order to verify his identity.
4. The investigative consumer reporting agency shall provide trained personnel to explain to the consumer any information furnished him pursuant to Section 1786.10.
5. The investigative consumer reporting agency shall provide a written explanation of any coded information contained in files maintained on a consumer. This written explanation shall be distributed whenever a file is provided to a consumer for visual inspection as required under Section 1786.22.
6. The consumer shall be permitted to be accompanied by one other person of his choosing, who shall furnish reasonable identification. An investigative consumer reporting agency may require the consumer to furnish a written statement granting permission to the consumer reporting agency to discuss the consumer's file in such person's presence



## **Drug Screen Policy**

**A nursing applicant, conditionally accepted into the nursing program, must have a negative urine drug test to be eligible for admission and to remain in the nursing program.**

The drug screen follows the National Institute on Drug Abuse guidelines and screens for 10 substances, as designated in the Substance Abuse Panel 10, "SAP 10." These substances are: amphetamines, barbiturates, benzodiazepines, cocaine metabolites, marijuana metabolites, methadone, opiates, phencyclidine, and propoxyphene. SAP 10 test results that fall outside of any of the acceptable ranges are considered positive test results and are automatically sent for a separate confirmatory test by a gas chromatography mass spectrometry method. If these results are positive, the test results are sent to a medical review officer who will review the results. The medical review officer will then contact the student to determine if there is a valid prescription for the drug in question. If a valid prescription exists and is verified, the test result will be deemed negative and acceptable.

### **Procedure**

1. Complete the online process for drug testing.
2. The applicant will go to the laboratory and submit the urine specimen by the due date.
3. The laboratory will submit the results to the vendor. The results may take up to 10 days. The vendor will then provide the results to Los Medanos College.
4. The applicant will need to submit another urine specimen at an additional cost to the applicant if:
  - the applicant's urine is diluted, and the test cannot be performed
  - the laboratory reports questionable specimen collection\*
5. A positive drug test makes the nursing applicant ineligible for admission into the nursing program for the academic year. The applicant will need to reapply as indicated in the Nursing Application Handbook and comply with any new selection criteria for the application year.

### **Additional Information**

**\*If questionable specimen collection is documented by the laboratory, the applicant must adhere to any recommended guidelines for submission of a follow-up specimen.**

**Recommended guidelines may include but are not limited to:**

- direct observed specimen collection
- additional costs to the applicant (\$100.00 or more)
