Community College Immigration Services

- In 2018, CA Assembly Bill 1809 passed appropriating \$10 million for the State to contract with qualified legal non-profit organizations to provide immigration legal services and support CA community college campuses.
- The State of CA selected IIBA as 1 of 10 legal providers to provide immigration services to ALL CCC students, staff, and faculty through the Community College Immigration Services Program.
- Consultations are free, confidential, and translators are available.



Dept of Homeland Security

- ICE: Immigration Customs Enforcement identifies and apprehends removable undocumented individuals
- CBP: Custom & Border Protections *secure borders*
- USCIS: U.S. Citizenship & Immigration Services processes immigration applications and sets policies for services
- HSI: Homeland Security Investigations largest investigative arm of DHS

Your Rights



To Remain Silent & NOT Disclose

Your immigration status, where you were born or how you entered the U.S.



To Have an Attorney



To NOT open the door

ICE needs a warrant signed by a judge to enter. Do not open!



To NOT sign

Never sign documents without first speaking to a lawyer

KNOW YOUR RIGHTS!

- -In your home
- -On the street
- -In your car
- -In detention



- Don't Open the Door! Speak to agents through the door.
 Everyone inside can remain silent. If agents don't speak your language, ask for an interpreter
- Ask to see warrant. ICE can only enter with force with a warrant with the name of someone who lives there and signed by a judge (but that's very rare). Your best protection is to NOT OPEN THE DOOR

IF STOPPED BY POLICE OR ICE OUTSIDE THE HOME:

- Stay calm. Don't run. Don't argue. Don't resist. Ask if you are free to leave. If yes, walk away.
- You have a right to remain silent. You do not have to answer questions about where you were born, whether you are a U.S. citizen, or how you entered the country
- You can refuse to let them search yourself or your belongings



The Red Card reminds you of your rights, and tells you what you can say to an ICE OFFICER.

Usted tiene derechos constitucionales.

- NO ABRA LA PUERTA SI UN AGENTE DEL SERVICIO DE INMIGRACION ESTA TOCANDO A LA PUERTA.
- NO CONTESTE NINGUNA PREGUNTA DEL AGENTE DEL SERVICIO DE INMIGRACION SI EL TRATA DE HABLAR CON USTED. Usted tiene derecho a mantenerse callado. No tiene que dar su nombre al agente. Si está en el trabajo, pregunte al agente si está libre para salir y si el agente dice que sí, váyase. Usted tiene derecho de hablar con un abogado.
- ENTREGUE ESTA TARJETA AL AGENTE. NO ABRA LA PUERTA

I do not wish to speak with you, answer your questions, or sign or hand you any documents based on my 5th Amendment rights under the United States Constitution.

I do not give you permission to enter my home based on my
4th Amendment rights under the United States Constitution
unless you have a warrant to enter, signed by a judge or
magistrate with my name on it that you slide under the door. I
do not give you permission to search any of my belongings
based on my 4th Amendment rights.

I choose to exercise my constitutional rights.

Practice Saying Your Rights Out Loud

I wish to exercise my right to remain silent.

I don't agree to this search.

I want to speak to an attorney.

I refuse to sign anything or show any document until I speak to a lawyer.

KNOW YOUR RIGHTS!

- -In your home
- -On the street
- -In your car
- -In detention

IF ICE DETAINS YOU:

- Remain silent. Do not lie about your citizenship status or show any false documents.
- If needed, assert your right to speak to a lawyer and make a phone call. Refuse to sign any papers before you talk to a lawyer.
- If needed, ask for an interpreter.

IF ICE DETAINS YOUR FAMILY MEMBER:

- Call your County's Rapid Response Line immediately to report detention and seek assistance

KNOW YOUR RIGHTS!

ICE TELLS LIES

ICE uses tricks and lies to get people to give them information or come outside: they pretend to be local police; they pretend they are investigating something; they pretend you are the victim of a crime; they don't wear uniforms

DON'T FALL FOR THEIR TRICKS!



Types of Warrants

Arrest Warrant

Identifies a person by name or description to be arrested

Search Warrants

Identifies address to be searched and items to be taken into custody

ICE Warrant of removal/deportation

NOT a judicial warrant

Remember, do not open the door to your home or private areas to ICE unless ICE has a judicial warrant.

Prepare For an ICE Encounter

- Do not panic or run. Remain as calm as possible.
- Know your rights (remain silent, speak to an attorney, do not agree to any search without a judicial warrant)
- If you are home, do not open the door to an ICE agent unless they have a
 judicial warrant.
- What documents should you carry?
 - O Valid work permit, green card, CA state ID or driver's license
 - Red cards
 - O DO NOT CARRY:
 - Passport or birth certificate showing country of origin
 - False identity documents or false immigration documents

Make a Child Care and Family Preparedness Plan

Who will care for your children?

- List of emergency contacts, including family and attorneys
- Complete a Caregiver's Authorization Affidavit (only in CA)

STEPS TO PROTECT YOURSELF

Collect documentation

Make sure you have documentation ready showing that you have lived in the U.S. for at least 2 years.

Proof of lawful entry
Proof you have a pending
application

Expanded use of "expedited removal"

- Previously- against people apprehended within 100 miles of the border and within 14 days of their arrival.
- Now- against any undocumented person who did not enter on parole or with a visa and who cannot prove they have been in the U.S. continuously for two years before the arrest.
- Exceptions: unaccompanied minors and undocumented persons who states fear of return

STEPS TO TAKE NOW TO PROTECT YOURSELF



Save Money

Save money for a bond or attorney, should you need it.





Do Not Commit Crimes

Including DUIs or using/possessing marijuana (it is a federal offense under U.S. immigration law).

AVOID IMMIGRATION FRAUD!



- In the U.S. only attorneys and accredited representatives can give legal immigration advice, NOT NOTARIES.
- Verify if you are working with a real attorney. In CA, visit calbar.org.
- If someone promises you something that is too good to be true, it probably is a lie.

What Can Allies Do During an ICE Encounter



- Video record, take photos and document the ICE activity, if you can safely do so. Don't interfere with ICE.
- Write down names or badge numbers of ICE agents.
- Call Rapid Response Network in your area.
- If someone is detained, they can be found at locator.ice.gov
